

STATION SETS
LOCAL BATTERY
SELECTION FOR GENERAL USE

1.00 INTRODUCTION

This section covers the selection of local battery talking common battery signaling, dial and manual station sets for general use. It also includes information on message rate service and selection of colored sets.

2.00 GENERAL

2.01 Information is contained in tabular form and includes the following:

- Selection by class of service as furnished by Western Electric Company.
- Indication of sets which require modification.
- Indication of sets to be used under particular station conditions.

2.02 Local battery sets are normally used in Zone L and the 6-type dial should be used in this zone.

- Choice of network for these sets is included in the section entitled Transmission Zoning.
- Ringer limitations are included in the section entitled Ringing Bridge Limitations.
- F4 or F5 handsets should be used with local battery sets.

3.00 MESSAGE RATE SERVICE

Local battery sets may be used for individual and 2-party line manual message rate service, but they cannot be used for tip-party identification on dial service.

4.00 SELECTION OF COLORED SETS

Selection information concerning colored sets is contained in Table A.
