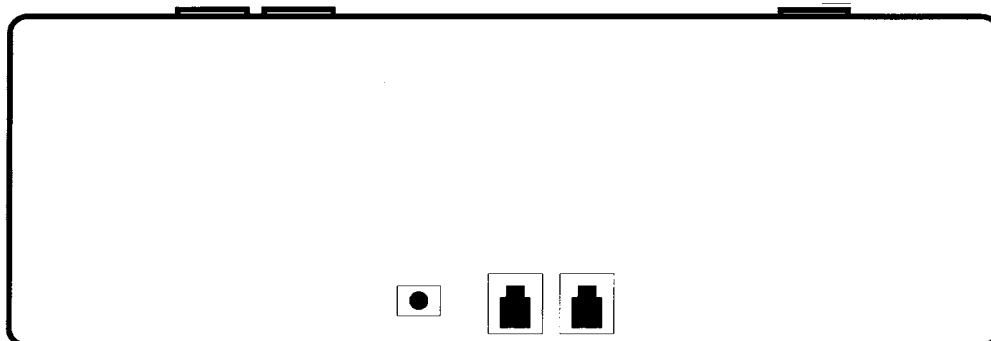

SETTING UP



For use with standard Caller ID service (displays name/number when the phone rings). Does not display Call Waiting Caller ID. Requires subscription to Caller ID service from your local phone company.

- 1 If desired, a phone or answering device can be connected to the PHONE jack.
- 2 Connect the LINE jack to a working phone outlet.
- 3 Connect AC Adaptor to power jack and plug into AC power.

CLOCK FUNCTION

When idle, Telnote functions as a clock. The time is set by the Caller ID signal from the telephone line and does not require manual setting.

NOTE: After initial setup, the correct local time will be set automatically when the first call is received.

RECEIVING CALLER ID

When the phone rings, Telnote displays incoming Caller ID information. The name of the calling party is displayed first, followed by the calling number. The display continues to alternate between name and number as long as the phone continues to ring.

If the calling party's name is not sent, the calling number alone is displayed. If the calling number is not sent, the display indicates that the Caller ID information is unavailable.

UNAVAILABLE

If the calling party blocks the sending of his Caller ID information, the display indicates that the call is anonymous.

ANONYMOUS

When ringing ends, the display reverts to indication of the current time. Calls are counted as they are received and the number of new calls is displayed along with the time.

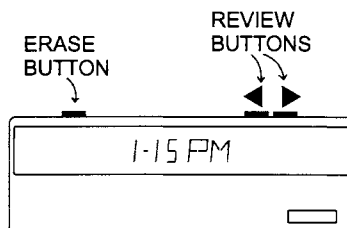
NEW CALL COUNTER

CALL MEMORY

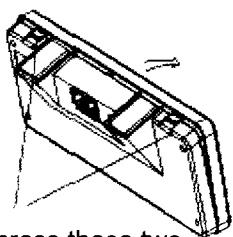
Telnote stores a maximum of 25 calls. Three pushbuttons access the memory. You can browse through your calls using the REVIEW buttons. Press and release the ◀ button once to see the most recent call received. The caller's name, time and date of the call, and the caller's phone number will be displayed one after the other. Press ◀ again to see the next most recent call. To begin with the oldest call, press the ▶ button.

After any review of received calls, the display will only indicate the current time. The count of new calls will begin to appear on the left of the display as soon as the next incoming call is received.

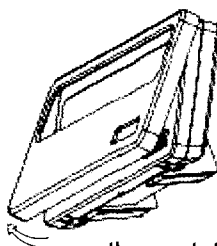
If the ERASE button is pressed, held until the display goes blank, and then released at any time during the review of a stored call, that call is then erased from the list, and the next call in the list is immediately displayed. The entire memory may be erased while in the clock mode by pressing and holding the ERASE button until the MEMORY EMPTY message appears.



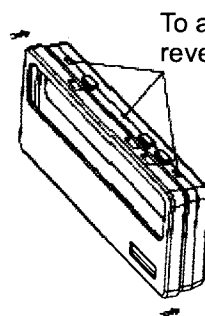
CHANGING THE COLOR SKINS

TROUBLESHOOTING

1. Initial Time Setting Is Inaccurate

The time setting will probably not be accurate when you first power up your Telnote. The correct time will be set when the first call is received.

2. Time Inaccurate Due To Daylight Savings Time Change

Telnote will adjust to the correct time with the first call received after Daylight Savings Time goes into effect.

3. No Display Of Incoming Caller ID Information

a. Don't answer the phone too soon.

The Caller ID signal is sent over the phone line between the first and second rings of a new call. If you or your answering machine pick up on the first ring, the Caller ID signal will be interrupted and not captured by the Telnote. Always wait until the second ring to answer, and set your answering machine to answer no sooner than the second ring.

b. Check the phone line connection.

The Telnote display should go blank during the first ring of a new call. If this does not happen, check that the phone jack you are using is good by verifying its operation with a telephone connected.

c. Make sure Caller ID service is enabled.

Telnote operation requires that you subscribe to Caller ID service from your local phone company. If you do not have this service, contact your local provider to arrange it.

4. Display Blinks

It is normal for the display to go blank momentarily when the phone rings. This may also occur when dialing out if pulse ("rotary dial") dialing is used.
