DIGITAL DATA SYSTEM

1. GENERAL

1.001 This addendum supplements Section 314-960-100, Issue 1. Place this pink sheet ahead of Page 1 of the section.

1.002 This addendum is issued for the following reasons:

- (a) To change the section title
- (b) To add an additional code to the F-specification to properly identify the power unit
- (c) To add another type of second-stage multiplexer
- (d) To add a caution about switching the power off before removing or inserting the PU
- (e) To add information to Fig. 1 for clarification
- (f) To correct information regarding the interface unit in Fig. 2
- (g) To add information to Fig. 3 to specify what type of equipment the interface cable goes to
- (h) To add examples of terminating equipment
- (i) To add relevant sections to the list of references.

2. CHANGES TO SECTION

2.001 On Page 1, change the section title to DS-1 Signal Access Unit and Auxiliary Circuits, Description, Digital Data System.

2.002 On Page 3/4, Fig. 2, Page 5, last bullet of paragraph 2.03, and Page 10, heading, add

(307A) to the F-specification as follows: (307A/F60513).

2.003 On Page 1, paragraph 1.04, delete the word "or" between T1DM and T1WB4, place a comma after T1DM and after T1WB4, and add the words "or T1WB5."

2.004 On Page 10, at the beginning of paragraph 3.23, add the following:

Caution: Turn the power switch off before removing or inserting the PU.

2.005 On Page 2, Fig. 1, inside the rectangle representing the DS-1 Signal Access Unit (DSAU), add a small rectangle enclosing EQ(GRP 1) on the left-hand side at the output of the DSAU and another small rectangle enclosing EQ(GRP 1,2,3) on the right-hand side at the output of the DSAU.

2.006 On Page 3/4, left-hand side of Fig. 2, change HI 198 INTERFACE UNIT to HL 198 INTERFACE UNIT.

2.007 On Page 6, right-hand corner of Fig. 3, delete the words "TEST EQUIPMENT" and revise the wording as follows: INTERFACE CABLE TO DATA TEST SYSTEM.

2.008 On Page 11 at the end of paragraph 3.24, add the following: (ie, T1DM or T1WB4/5).

2.009 On Page 16, Part 5, REFERENCES, add the following:

314-901-530 Bit Access Test System (BATS) and Line Access Test System
